Dear Shareholder,

Invitation to Participate in Share Purchase Plan

On 11 November 2019, Norwest Energy NL (ACN 078 301 505) (**Norwest or the Company**) announced that it had received commitments to raise \$3.25 million via a placement of securities to a range of sophisticated and institutional investors at \$0.0035 per fully paid ordinary shares (**Shares**) together with one free attaching option for every two Shares subscribed for, exercisable at \$0.006 on or before the date that is two years from the date of issue (**Options**)(**Placement**). The Placement has subsequently been increased to \$3.3 million.

The Placement will be undertaken in two separate tranches with 661,670,831 Shares having been issued under the Company's placement capacity under Listing Rules 7.1 and 7.1A, and 264,014,873 Shares together with all the Options under the Placement to be the subject of shareholder approval at a general meeting to be convened on 24 December 2019 (**General Meeting**).

The Directors intend to participate in the Placement for up to \$60,000, subject to the receipt of necessary shareholder approvals at the General Meeting.

In order to provide Eligible Shareholders (defined below) with the ability to participate in the Company's capital raising activities, the Company is pleased to provide details of a Share Purchase Plan (**Plan**).

Under the Plan, Eligible Shareholders will have the opportunity to purchase up to \$30,000 worth of Shares at the same price as the Placement, irrespective of the size of their shareholding, without incurring brokerage or transaction costs. Eligible Shareholders will be invited to lodge an application for the 71,428,571 free Options via a separate offer to be made under a prospectus, subject to receipt of shareholder approval at the General Meeting (**Option Offer**). The Options are therefore not being offered under this Plan and the Option Offer will be undertaken in the new year.

The offer under the Plan (**Offer**) currently intends to raise \$500,000 on the terms and conditions (**Terms and Conditions**) contained in this letter. In conjunction with the Placement, this will provide the Company with additional funds of approximately \$3.8 million.

Shareholders Eligible to Participate in the Plan

Participation under the Plan is optional and is available exclusively to shareholders of the Company who are registered as holders of Shares at 4.00pm (Perth time) on 8 November 2019 (**Record Date**) and whose registered address is in Australia or New Zealand (**Eligible Shareholders**).

Share Purchase Plan

The Plan entitles Eligible Shareholders, irrespective of the size of their shareholding, to purchase up to \$30,000 worth of Shares at an issue price of \$0.0035 (**Price**) being the same price as the Shares offered to sophisticated and professional investors under the Placement. The Price is a discount of 22.3% to \$0.0045 (being the volume weighted average market price (**VWAP**) for the Shares over the last 5 days on which sales in the Shares were recorded before the day on which the Plan was announced. The Company has applied to ASX, and been granted, a waiver from the ASX Listing Rules to enable the Shares under the Plan to be priced at a discount greater to 20% of the 5-day VWAP prior to the day on which the Plan was announced.

Whilst the Company intends to raise \$500,000 under the Plan. If applications received are for greater than \$500,000, the Company intends to allocate the Shares under the Plan on the basis of time of receipt of those applications. Therefore, Eligible Shareholders are encouraged to get their applications in as early as possible.

The directors of the Company are eligible to participate under the Plan, however do not intend to participate in order to leave greater capacity for Eligible Shareholders. The participation of the Directors in the Placement is subject to the approval of shareholders.

An application form for the Plan (**Application Form**) is included in this package.

Current Activities

Details of the Company's current activities are set out in the announcements made by the Company to the ASX and are available from the ASX, or the Company's website at www.norwestenergy.com.au.

As announced on 11 November 2019, the funds raised under the Plan and the Placement will be used for:

- drilling costs associated with the Company's 20% interest of exploration drilling in Permit EP 368 in the Perth Basin (expected to spud 1H 2020);
- planning and preparation for operations to meet future work commitments within EP 368 and EP 426;
- desktop studies on the Company's other Perth Basin interests including Xanadu oil discovery;
- partial repayment of the Sundowner International Convertible Loan Facility; and
- general working capital.

How much can you invest?

Eligible Shareholders may each apply for a maximum of \$30,000 worth of Shares and a minimum of \$2,000 worth of Shares under the Plan.

Relationship of Issue Price with Market Price

On the last trading day immediately prior to the announcement date of the Offer, the closing price of the Shares traded on ASX was \$0.0045. The market price of Shares in the Company may rise and fall between the date of the Offer and the date that any Shares are issued to you as a result of your application under this Offer.

By making an application under this Offer and applying for Shares under the Plan, each Eligible Shareholder will be acknowledging that although the purchase Price is at a discount, Shares are a speculative investment and the price of Shares on ASX may change between the date of the Company announcing its intention to make an Offer and the date of issue of Shares under that Offer and that the value of the Shares received under the Plan may rise or fall accordingly.

The Board recommends that you obtain your own financial and taxation advice in relation to the Offer and consider price movements of Shares in the Company prior to making an application under this Offer.

Additional Information and Important Dates

The offer of Shares under the Plan is made in accordance with ASIC Corporations (Share and Interest Purchase Plans) Instrument 2019/547 and therefore does not require a prospectus for the purposes of Chapter 6D of the Corporations Act (2001) (Cth) (**Corporations Act**).

The Offer cannot be transferred and the Directors of the Company reserve the right in their absolute discretion to reject, or scale back, on an equitable basis, any application. Shares allotted under the Plan will be issued no later than 10 business days after the Closing Date of the Offer. Application for quotation on ASX of the new Shares will be made immediately following the issue of those Shares.

The amount proposed to be raised under the Offer is \$500,000. The Company, however, reserves absolute discretion regarding the final amount raised under the Offer, and may accept oversubscription subject to the ASX Listing Rules.

In the event of oversubscription by the Closing Date the Directors intend to allocate the Shares under the Offer on the basis of the order of receipt of applications. Accordingly, Eligible Shareholders are encouraged to return their Application Form as soon as possible.

If the Company rejects or scales-back an application or purported application, the Company will promptly return to the shareholder the relevant application monies, without interest.

Norwest Energy NL ACN 078 301 505 **Share Purchase Plan - Terms and Conditions**

Purpose

The purpose of the Share Purchase Plan (**the Plan**), which will be conducted in conjunction with the Placement, is to offer shareholders of Norwest Energy NL (**Norwest or the Company**) the opportunity to acquire additional fully paid ordinary shares in the Company (**Shares**) up to a maximum of \$30,000 (and a minimum of \$2,000 worth of Shares. The issue price of \$0.0035 under the Plan will be at a discount of 22.3% to the volume weighted average market price for Shares over the last 5 days on which sales in the Shares were recorded on the financial market operated by ASX Limited (**ASX**) before the day on which the Plan was announced which was \$0.0045. The Company seeks to raise \$500,000 under the Plan. The Shares will also be issued without the need to pay brokerage costs and without the need for the Company to issue a prospectus. The Plan is governed upon such terms and conditions as the board of directors of the Company, in its absolute discretion, sees fit.

No Financial Advice

This document does not provide financial advice and has been prepared without taking account of any person's investment objectives, financial situation or particular needs. You should consider the appropriateness of participating in the Plan having regard to your investment objectives, financial situation or particular needs. Shareholders should seek independent financial and taxation advice before making any investment decision in relation to these matters.

Shareholders Eligible to Participate

Holders of Shares that are registered with an Australian or New Zealand address at the Record Date are eligible shareholders (**Eligible Shareholders**) and may participate in the Plan, unless such registered shareholder holds Shares on behalf of another person who resides outside Australia or New Zealand. Due to foreign securities laws, it is not practical for shareholders (or beneficial shareholders) resident in other countries to be offered the opportunity to participate in the Plan.
